Proceeds From Sale of Rickman Center

Move that an unrestricted Rickman Legacy Fund be created and held at CCF\OGMP, and invested as if it were an endowment, with the proceeds earmarked for Mid-America ministries (with 75% of each year's distribution to go to Mid-America Youth and Outdoor Ministries and 25% to go for Mid-America Leader Development, with allocations subject to change by the governing Board of the Christian Church (Disciples of Christ) of Mid-America).

Move that the unrestricted Rickman Legacy Fund receive \$1 million from the sale of Rickman; and that after the costs of sale, the remaining balance from the sale go to the operating reserve funds of the Region, previously known as the Historical Fund.
